Tightly closed. Dry. Keep away from heat and sources of ignition. Keep away from direct sunlight.Performing regular visual inspections of membranes and keeping accurate records of recommended shelf life can reduce the risk of membrane deterioration. Shelf-life limited when kept above +25°C. Recommended storage humidity: 30 - 70 %. Verify on a regular basis housekeeping, temperature and humidity.
