CUSTOMER PERSONAL DATA

DISCLOSURE TO THIRD PARTIES

LWS does not sell your data to third parties and only provides this data if necessary for the execution of our services with you or to comply with a legal obligation (such as the tax authorities). This is done on the basis of a legal basis or a cooperation agreement.

EXTRAORDINARY AND/OR SENSITIVE PERSONAL DATA (MINORS)

LWS does not store sensitive personal information as political preference, race, religion or health. Our website does not intend to collect data about website visitors who are younger than 16 years.
