

Restricted Use License

This Restricted Use License sets out the terms and conditions under which certain Reprogramming Kits ("Products") are being provided to Recipient ("Licensee") by Stemgent Inc. pursuant to a license agreement between Stemgent Inc. and the Whitehead Institute.

- 1. Products are for basic research use only by the Licensee and only pursuant to the terms of this license agreement. LICENSEE SHALL USE THE PRODUCTS SOLELY FOR THE PURPOSE OF CONDUCTING INTERNAL, NONCOMMERCIAL RESEARCH. PURCHASER WILL NOT SELL, TRANSFER, DISCLOSE OR OTHERWISE PROVIDE ACCESS TO THE PRODUCTS OR ANY DESCENDENTS/PROGENY TO ANY PERSON OR ENTITY.
- 2. Licensee understands that the Products, under certain circumstances, may have biological and/or chemical properties that are unpredictable and unknown at the time of transfer, that they are to be used with caution and prudence, and are not to be used for testing in or treatment of humans or animals.

This product is intended for basic research purposes only including without limitation basic research having as its primary purpose understanding the biology or pathology of cells or cell lines and diseases or disorders affecting them. It may not be used for (i) any human clinical use or veterinary use including without limitation therapeutic, prophylactic or diagnostic use, (ii) discovery, development, or manufacturing of pharmaceutical products (including without limitation assay development or cell line generation for drug discovery or drug development, screening of chemical and/or biological compounds for the identification of pharmaceutically active agents, or preclinical testing, or services related to the above), or (iii) conducting services for the purpose of discovering or developing pharmaceutical products. Further, this product may not be used to manufacture or as part of or for any commercial products or services, other than performing basic research as described above on behalf of others. This product may not be resold, redistributed or transferred.

Any use of this product for any of the above-mentioned purposes requires a license from the Whitehead Institute or one of its licensees, and the Whitehead Institute and its exclusive licensees will be express third-party beneficiaries of the foregoing restrictions. The foregoing restrictions amount to a restricted license under applicable patent and other intellectual property rights.

- 6. IN NO EVENT SHALL STEMGENT INC. BE LIABLE FOR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES IN CONNECTION WITH THIS RESTRICTED USE LICENSE AGREEMENT OR THE LICENSE GRANTED HEREUNDER.
- 7. This Agreement shall commence upon opening of the packaging (the "Effective Date"), and continue until the Products are used in accordance with Section 1. Upon termination of this Agreement, no Products or descendents or progeny shall remain in Licensee's possession.
