Product Description

TIE 2 is a receptor tyrosine kinase that is expressed principally on vascular endothelium. Disrupting TIE 2 function in mice results in embryonic lethality with defects in embryonic vasculature, suggesting a role in blood vessel maturation and maintenance.

Angiopoietin-1 is a secreted growth factor that binds to and activates the TIE 2 receptor tyrosine kinase. SHP2 and GRB2 are recruited to the activated TIE 2 kinase domain and are part of the cellular responses that mediate TIE 2 function. TIE 2 expression is upregulated in the endothelium of vascular "hot spots" in human breast cancer specimens. However, TIE 2 is also overexpressed in areas of active angiogenesis in normal tissues. This recombinant product was expressed by baculovirus in *Sf*9 cells using an N-terminal GST-tag. The gene accession number is NM 000459. It is supplied in 50 mM Tris-HCl, pH 7.5, with 150 mM NaCl, 0.25 mM DTT, 0.1 mM EGTA, 0.1 mM EDTA, 0.1 mM PMSF, and 25% glycerol.

>90% (densitometry)




Procedure

Preparation Instructions

Kinase Assay Buffer -25 mM MOPS, pH 7.2, 12.5 mM glycerol 2-phosphate, 20 mM MgCl₂, 12.5 mM MnCl₂, 5 mM EGTA, and 2 mM EDTA. Just prior to use, add DTT to a final concentration of 0.25 mM.

Kinase Dilution Buffer – Dilute the Kinase Assay Buffer 5-fold with a 50 ng/μl BSA solution.

Kinase Solution – Dilute the Active TIE 2 (0.1 μ g/ μ l) with Kinase Dilution Buffer to the desired concentration. Note: The lot-specific specific activity plot may be used as a guideline (see Figure 2). It is recommended that the researcher perform a serial dilution of Active TIE 2 kinase for optimal results.

10 mM ATP Stock Solution – Dissolve 55 mg of ATP in 10 ml of Kinase Assay Buffer. Store in 200 μ l aliquots at –20 °C.

 γ -³²P-ATP Assay Cocktail (250 μM) – Combine 5.75 ml of Kinase Assay Buffer, 150 μl of 10 mM ATP Stock Solution, 100 μl of γ -³²P-ATP (1 mCi/100 μl). Store in 1 ml aliquots at –20 °C.

Substrate Solution – Dissolve the synthetic peptide substrate Poly (Glu:Tyr, 4:1) in water at a final concentration of 1 mg/ml.

1% phosphoric acid solution – Dilute 10 ml of concentrated phosphoric acid to a final volume of 1 L with water.

Kinase Assay

This assay involves the use of the ³²P radioisotope. All institutional guidelines regarding the use of radioisotopes should be followed.

- 1. Thaw the Active TIE 2, Kinase Assay Buffer, Substrate Solution, and Kinase Dilution Buffer on ice. The γ -32P-ATP Assay Cocktail may be thawed at room temperature.
- 2. In a pre-cooled microcentrifuge tube, add the following solutions to a volume of 20 μl:

10 μl of Kinase Solution

10 μl of Substrate Solution

- 3. Set up a blank control as outlined in step 2, substituting 10 μ l of cold water (4 °C) for the Substrate Solution.
- 4. Initiate each reaction with the addition of 5 μ l of the γ - 32 P-ATP Assay Cocktail, bringing the final reaction volume to 25 μ l. Incubate the mixture in a water bath at 30 °C for 15 minutes.
- After the 15 minute incubation, stop the reaction by spotting 20 μl of the reaction mixture onto an individually precut strip of phosphocellulose P81 paper.

- Air dry the precut P81 strip and sequentially wash in the 1% phosphoric acid solution with constant gentle stirring. It is recommended the strips be washed a total of 3 times of ~10 minutes each.
- 7. Set up a radioactive control to measure the total γ - 32 P-ATP counts introduced into the reaction. Spot 5 μ l of the γ - 32 P-ATP Assay Cocktail on a precut P81 strip. Dry the sample for 2 minutes and read the counts. Do not wash this sample.
- 8. Count the radioactivity on the P81 paper in the presence of scintillation fluid in a scintillation counter.
- 9. Determine the corrected cpm by subtracting the blank control value (see step 3) from each sample and calculate the kinase specific activity

Calculations:

1. Specific Radioactivity (SR) of ATP (cpm/nmole)

SR =

cpm – value from control (step 7) nmole – 1.25 nmole (5 μl of 250 μM ATP Assav Cocktail)

SR = specific radioactivity of the ATP (cpm/nmole ATP) Δ cpm = cpm of the sample – cpm of the blank (step 3) 25 = total reaction volume

20 = spot volume

E = amount of enzyme (mg)
